Completed Packets must be processed through the Principal's Secretary for submission to the District Office

*Board Approval Required for Trips That Are:

- Overnight
- Over 60 miles
- Out-of-state/country
 - Request forms should be submitted no later than 4 weeks prior to contemplated departure date

Student Activity Field Trip Request Form and required information:

- The Purpose of Trip must have a specific description
- Destination Please specify city and state, location
- Student to chaperone ratio is 15:1
- At least one chaperone attending trip must be certificated East Side staff
- When female and male students are attending an overnight trip, there must be male and female chaperones
- Provide list of students with ID number
- Detailed trip itinerary Must have departure times, and estimated activity/location and times, Hotel and Flight Information
 - Airbnb is not a an approved form of lodging
- Chaperone details i.e. name, role/title, contact information (All non-staff chaperones must go through volunteer fingerprinting process with HR)

Field Trip Authorization and Release Form (2 pages):

• Completed for each student and kept on file at site

School Bus Request Form (Forms are available on the intranet under Transportation):

• Site is responsible for contacting transportation department to secure bus

Self-Driven Transportation Authorization Form:

• To be completed by each student driving themselves, or riding as a passenger in a vehicle driven by an adult

Personal Automobile Use Form:

- Form must be completed by each chaperone driving their own vehicle
- Form must be signed by site principal
- Must include copy of driver's license
- Must include copy of proof of auto insurance

Chartered Bus and Other Rented Vehicle(s) - only allowed if district transportation cannot provide service:

- Copy of Invoice/Agreement must be signed by General Purchasing Director
- Current insurance certificate of company
 - *Please refer to our general purchasing department regarding rental vehicle guidelines and policies

NOTE: Before you contract a chartered bus company, you must first contact the District transportation department using the bus request form. If they cannot accommodate you, they will provide a denial stamp. A copy of the form indicating their unavailability must accompany your RPO for other transportation expenses

Process a Request for Purchase Order or Request for Check:

• For cost of chartered bus, rented vehicle(s), air travel, admissions fee, etc. (provide all completed field trip documents as backup)

Air Travel:

- Provide flight itinerary
- Must purchase traveler's insurance (with ticket or separately)

NOTE: Per federal regulations, bag lunches must be offered to all students for trips during the school day. Contact site kitchen manager at least one week in advance.

Transportation/Bus Request

Procedure

- 1. All bus transportation requests must be reviewed by the transportation department.
- 2. School submits completed Bus Request form #3000-53 with a copy of the Student Activity Field Trip Request form to the Transportation Department. (Form #3000-53 available online.)
- 3. Transportation will review request for bus availability.
- 4. If request is approved, transportation will assign a district bus, schedule the trip and return confirmation to the school.
- 5. If a district bus is <u>not</u> available and the request is "denied" by district transportation, transportation will send request back to the school advising school to use outside vendor services from the district's approved vendor list.
 - a. The district's approved vendor list includes the following:
 - 1. Royal Coach Tours (408) 279-4801
 - 2. West Valley Charters (408) 371-1230
 - 3. San Jose Charters (408) 360-9883
 - 4. Laidlaw Transit (408) 971-3466
 - 5. Durham School Services (408) 377-6655
 - 6. School Transportation of America (STA) (408) 998-8275
- 6. If using an outside service, an RPO (Request for Purchase Order) must be submitted to Purchasing to confirm bus reservation.
- 7. A copy of the Student Activity Field Trip Request form and "denied" Bus Request form must be attached to the RPO.
- 8. When using outside services, teachers and/or field trip supervisors are responsible for making sure that the bus driver and the bus are certified. The driver must have the following:
 - b. California Commercial Driver License -Class: B and Endors: P
 - c. California Special Driver Certificate
 - 1. If there is a "restriction #6" on the certificate indicating "First Aid Test Waived", driver must also present a First Aid certificate.
 - 2. Certificate must indicate that it is certified for School Bus or School Pupil Activity Bus (SPAB) use
 - d. Medical Examiner's Certificate (check expiration date)
 - e. CHP inspection approval certificate. The date of the trip must not be more than 13 months from the "date certified".
- 9. Overnight trips, out-of-state trips and trips beyond 60 miles of district boundary must be approved by the Board and the Superintendent. Approvals must be obtained at least (4) weeks prior to trip date.
